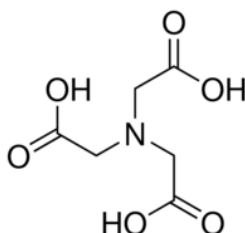

4.2. Most important symptoms and effects, both acute and delayed
